RE: Guaranteeing a Green Recovery across Europe in Next Generation EU - your role in excluding fossil fuels from the Recovery and Resilience Facility

We are writing to urge you to exclude fossil fuels from the scope of the Recovery and Resilience Facility (RRF), the largest envelope in Next Generation EU.

The European Parliament has demonstrated bold ambition in ensuring the EU's political framework is a true catalyst for the ecological transition in the EU and the creation of millions of future-proof jobs. The European Parliament's decision to increase the EU's 2030 climate target to 60% greenhouse gas reduction or the recent Environment Committee vote to ban fossil fuel subsidies from the RRF are just a few examples of this.

Investment decisions made today will shape European economies for decades to come, impacting our and the next generation's jobs and health. In particular, the 672.5 billion euros of the RRF have the capacity to transform the Union's economy. Continuing to finance fossil fuels, including gas, is unacceptable: it's in direct contradiction with the climate goals of the Parliament and of the EU as a whole, as well as with the objectives of the Paris agreement and, ultimately, with science.

Fossil gas is not a 'bridge solution' on the pathway towards climate neutrality. Methane, the primary component of gas, is a dangerous greenhouse gas over 84 times more damaging than CO2 emissionsⁱ. Fossil fuel subsidies distort markets, lock regions into fossil fuel dependency for decades, hamper the roll-out of cost competitive renewable energy and energy savings solutions and thus prevent the creation of millions of new jobs all over Europeⁱⁱ.

We, the Green 10, the ten largest environmental networks in Europe with more than 54 million members, urge you to exclude fossil fuels from the scope of the RRF, and to create an ambitious legal framework that will steer EU economies towards climate neutrality.

It is your responsibility to ensure that those investments contribute to a sustainable recovery.
